SECTION I - PURPOSE / DESCRIPTION

The PAZnia General Fund is established for any citizen of PAZnia for the purposes of furthering an individual's goals or toward that individual(s) utilizing the fund in order to further the cause of liberation and self-liberation for others.

SECTION II - CREATION OF THE FUND

The PAZnia General Fund ("The Fund") will be setup on a private, newly created Bitcoin (BTC) address and will be funded with the initial sum equivalent to \$1,000 (One-Thousand) USSA Dollars at the time of funding.

SECTION III - REQUIREMENTS TO UTILIZE SAID FUND

(A) The Fund shall be established and shall be in effect until the balance of the fund reaches 0.00 or near 0.00 BTC upon which time the fund will close after a period of no less than 45 (forty-five) days.

(B) An inquirer who wishes to seek invasion of the fund must be a citizen and/or contributor to PAZnia and must present proof of citizenship (e.g. PAZnian passport, PAZnia flag, PAZnia coin).

(C) Some examples of a valid and reasonable request from the fund are but not limited to furthering the cause of VONU and Self-Liberation, an individual: (i) wishes to utilize the fund in order to plant a garden on his/her land, (ii) needs to temporarily fund a food supply, (iii) any equipment needed to construct mesh networks or further the cause of crypto-anarchy, (iv) is destitute and needs money from the fund or without it risks re-joining the servile society, (v) needs to cover up front costs of publishing a liberty oriented book or pamphlet through Liberty Under Attack Publications ("LUA Pub"), (vi) wants to use the funds for black or grey market activities, (vii) needs to protect him/herself and his/her family by utilizing the fund to purchase protection, (viii) is using the fund to culture jam first realm culture and/or create new culture throughout the

31 PAZnian PAZ, (ix) A PAZnian citizen and/or a family member of a PAZNian  
32 citizen is captured and needs funds for release and/or legal defense.

#### 34 SECTION IV - INQUIRIES FOR INVASION OF THE FUND

35 All inquiries will be considered on a first hand basis and must be in writing and  
36 encrypted. Use of pseudonyms are encouraged. The creator of the fund reserves  
37 all rights to the fund and has the right to decline funding for any reason.

38 Inquiries can be submitted to [Josiah.warren@protonmail.com](mailto:Josiah.warren@protonmail.com) and will be  
39 answered as soon as possible. The inquiry must contain: (i) the individual's  
40 pseudonym, (ii) a brief description of need for the funds, (iii) the exact amount  
41 needed, (iv) if items are being purchased a manifest and/or invoice, (v) a valid  
42 and confirmed Bitcoin (BTC) address not originating from an exchange or  
43 coinbase.

#### 45 SECTION V - PROHIBITED USES OF THE FUND, ABUSE OF SAID FUND

46 The fund shall not be used to fund any State activities including but not limited  
47 to: (i) payment of taxes, (ii) purchase of materials that support law enforcement,  
48 military, or any welfare warfare schemes cooked up by State actors, (iii) funding  
49 political crusades in any way either indirectly or directly, (iv) pro-servile society  
50 first-realm propaganda, (v) creation of a culture of dependence on any  
51 individual, this is not a welfare program or a crutch. Any funds received from  
52 the fund are considered a gift.

53 Any citizen abuse of the fund will be dealt with in a respectful manner and in  
54 accordance with the PAZNian constitution and within the Non-Aggression  
55 Principal (NAP). Any abuse or use of funds that may be considered to be  
56 prohibited or unreasonable or not adhering to values of PAZNia and VONU will be  
57 required to pay back the fund with a 20% (twenty-percent) penalty.

#### 59 SECTION VI - DONATIONS TO THE FUND

60 Any citizen can make a donation to the fund by inquiring to the fund's creator at  
61 [Josiah.warren@protonmail.com](mailto:Josiah.warren@protonmail.com). Any funds given will be irreversible once they

62 are given. Such funds will become part of the fund and utilized in a responsible  
63 manner in accordance with fund principals outlined above.


64 The Fund will be created / funded on or around the month of February 2021.
